Introduction:

Chaitanya Bharathi is a registered Non Governmental Organization working for the Scheduled Tribes, Scheduled Castes and other Backward Community people of the vizianagaram district of Andhra Pradesh since 1991. Chaitanya Bharathi means "**Chaitanya**" stands for Generating awareness among all communities and "**Bharathi**" stands for the aspirations and hopes of the organization to extend its services though out India. It is actively involved in various programs like Child labour eradication, Rehabilitation, Youth development, women Development, Health and sanitation, safe drinking water and community forest management programs in the villages for the socio-economic development of the disadvantaged people of the vizianagaram district. Chaitanya Bharathi had a program based approach to improve the living standard of the marginalized sections of the community in different mandals of Vizianagaram District.

It is a secular, non political and nonprofit making voluntary development organization working for a change in the community and established in the year 1991 under the leadership of Mr. K.Manmadha Rao a committed social worker of repute. The organization is dealing with Swadhar Shelter Home and Helpline supported by Women and Child Welfare Dept. Ministry of HRD,GOI New Delhi, Short Stay Home, Family Counseling centre ,CRECHE canters supported by Central Social Welfare Board ,GOI, New Delhi , NCLP Project. Supported by Ministry of Labor, GOI, New Delhi and WE CLEAR Project supported by KKS, Germany. Sustainable Livelihood Enhancement and Enterprise Promotion (SLEEP) supported by HIVOS Netherlands and HIV\AIDS project supported by APSACS Hyderabad. Sustainable Handloom Based Livelihoods and Revival of Traditional Handloom Art Forms (IDC Livelihood Project): Supported by Microsoft India (R & D) Pvt Ltd, Hyderabad.

The Annual Report for the year **2021-22** covers different project activities for the upliftment of the community. It also covers overall projects of the organization and process of work .It is gratifying to note that we have made our every effort to fulfill the objectives of the organization and also for the overall development of the people.

SWADHAR GREH :

The economic, social and psychological needs are causing many problems to present day women, who are not equipped enough to face them. Especially for the women in difficult circumstances like widows, destitute and deserted women, women ex-prisoners, Victims of sexual abuse and Crimes, including those trafficked and rescued from brothel houses, migrant or refugee women, who have been rendered homeless, due to Natural calamities like floods, Cyclone, Earthquake etc., Mentally challenged women, women victims of terrorist violence etc. Sometimes society itself drives such women out of the system to lead lives of sub human existence. Sometimes vulnerable women in distress end up as beggars or prostitutes for their own survival and at times for survivals and maintenance of their dependent children. Marital conflicts and emotional disturbances are driving women out of their home. These women require sympathy; help and proper rehabilitation and guidance. Self-confidence should be instilled in them to face the situations. They should be given mental and financial support to readjust in their family or society or both.

Therefore "Swadhar" scheme is very much needed to cater the requirements of various types of women in distress in diverse situations under different conditions. This scheme supported the specific vulnerability of each group of women in difficult circumstances through a Home-based holistic and integrated approach. Such type of scheme is very highly helped in Vizianagaram to ensure the women in distress.

The female population who were in distress due to family tensions, disputes are unable to get immediate help. This type of scheme will be very useful to those women who are in difficult circumstances like destitute in danger, deserted women, victims of sexual abuse, widows, women and girls trafficked and rescued from brothel houses and women who are facing marital conflicts and emotional disturbances, girls failed in love etc.

The economic, social and psychological needs are causing many problems to the present day women and girls. Marital conflicts, family disputes and emotional disturbances are driving women out of their homes. These type of women and girls need the help of the scheme, because they can immediately avail the help. If we provide proper guidance and self confidence to them they do not take any unwanted and dangerous decision.

The Swadhar Greh has given valuable and necessary services to all the women and girls who are in distress or in difficult circumstances. Rescued the trafficked women and girls given the solutions to the problems to the women. Further it helped and guided the women to take proper support of the police, legal and medical nearby them. Therefore, Swadhar Greh is very much helpful to cater services to the women and girls who are in difficult conditions. This scheme extended support to the specific group of women who are in dire need. Therefore Chaitanya Bharathi focused mainly on Women and Child development and successfully implementing Swadhar Greh Project activities supported by the Ministry of Women and Child Development GOI, New Delhi. The project has been aimed to help the women and children for their overall development with the following activities.

- Rehabilitation
- Providing free accommodation and other basic needs
- Health and hygienic facilities
- Recreation
- Education to the children of the inmates.

- Awareness generation and counseling
- Vocational trainings
- Linkages with concerned departments
- Clinical an legal support
- Toll free phone facility
- Legal and psychological counselling.
- Referral services
- Review and monitoring by the home committee.

RESULTS:

- 38 inmates have been rehabilitated during this year through Swadhar Shelter Home.
- 30 inmates have been provided with basic needs along with health and hygiene facilities.

✤ All the inmates have been provided T.V. VCD, Caroms, Skipping, Radio, Luda etc. as a part of recreation.

- ✤ 30 inmates were provided with boxes, beddings etc.
- 12 inmates have been referred to Govt. hospital for necessary treatment.
- 07 inmates have learned basics in computer programmed.
- ✤ 08 inmates have been gained knowledge in tailoring and embroidery.
- O8 inmates have acquired knowledge in making decorative flowers.
- ✤ 374 women were generated awareness through 5 awareness camps in 5villages.
- 7 children of the 7 inmates have been enrolled in the normal school.
- Monitoring and review by the home committee through 4 meetings.

FAMILY COUNSELLING CENTRE :

The main objective of this family counseling centre is to resolve the family related disputes by mutual counseling and without going to the police or the court of law. Chaitanya Bharathi, with the help of counselors play the facilitator role in solving the

disputes. The disputes arise due to Dowry demand, divorce inter-caste marriages, love failures, extra marital relations, addiction to alcohol and drugs, economic crisis, personality differences, etc. Chaitanya Bharathi with the support of Dept. of Women and child Development, Central Social Welfare Board, GOI, New Delhi established the Centre at Vizianagaram to settle the family disputes with the following services.

- Counseling
- Legal aid
- Police assistance
- Short stay
- Vocational training
- Employment, financial aid.
- Referral services.
- Maintenance of resource directory
- Constitution of sub committee
- Awareness generation camps and publicity
- Convergence with line departments
- Mutual settlement

RESULTS

SUSTAINABLE LIVELIHOOD ENHANCEMENT AND ENTERPRISE PROMOTION

(SLEEP Project):

During the year 2021-22 Chaitanya Bharathi paid focus on the follow up of the Producers Organization Registered under APMACS ACT 1995 under the Sustainable Livelihood Enhancement and Enterprise Promotion project with an objective to empower the women in agriculture by making systematic intervention to enhance their participation and productivity also to create Sustainable livelihoods of rural women by establishing efficient local resource where women in these sectors gain more control over production, resources and manage the support systems based on the following activities for socio economic development of women in 7 villages of R.B. Puram Mandal in Vizianagaram district.

- 742 Farmers have been educated on the SHG concept, Organic /
 NKP agriculture practices through awareness camps and Training Programs
- 52 meetings have been conducted to generate awareness among the community on the society's project objectives and activities

Chaitanya Bharathi has been sanctioned HIV/AIDS Project by Andhra Pradesh State AIDS Control Society. The Project is being implemented in 10 mandals of Vizianagaram district namely Nellimarla, Gurla, Garividi, Chipurupalli, Merakamudidam, Balijipeta, Terlam, Badangi,and Mentada Mandal for 964 FSW and 136 MSM with the following components.

Sustainable Handloom Based Livelihoods and Revival of Traditional Handloom

Art Forms (IDC Livelihoods Project):

Chaitanya Bharathi with the support of Microsoft (R&D) India Pvt.Ltd Initiated the project in Telangana State with an objective to capacitate the Handloom weavers to produce High quality Hand wove products using traditional skills with contemporary designs. During the year 2021-22 Microsoft's support to handloom weavers has been extremely important. It has helped the weavers to continue and revival of the some of the forgotten handloom art forms in Telangana namely natural dyed, Telia, Rumal, Gollabhama extra weft saries and kuppadam 3 shuttle Gadwal saries.

<u>Results :</u>

- Skills of the weavers were enhanced through design and dyeing workshops
- Social recognition for their skills

- Fair wages and continuous work
- 25 handloom weavers spread in 4 districts of Telangana namely Yadadri Bhuvan Giri, Siddipet, Mahbubnagar and Gadwall
- Weavers were supported with design inputs, working capital and market access
- > Upscale the skills of the weavers in design through workshops
- > 10560 mts of fabric have been woven and 7500 mts was sold successfully
- 10 Lakh Rupees was circulated for purchase of raw materials and providing sustainable livelihoods.
- Handloom products of the weavers have been sold through National Exhibitions at Hyderabad, Bangalore, Mumbai and Kolkata.
- > 125 women have been trained in garment making
- > 35 women have been trained in Banjara needle work
- Weavers, artisans and garment makers got 25 30% higher wages
- Door delivery of raw material, wages to weavers and also collection of finished products from the door steps.
- Market exposure to the weavers in the form of end customer preferences of designs, colors and price pattern.
- > Updated the technical skills of the weavers by providing technical inputs.
- > Assured regular income through continuous and regular work.
- Enabling loans to weavers through bank linkages.
- 10 organic farmers in Janagaon and Moinabad are encouraged to grow organic cotton
- Extension of organic cotton growing to another 30 failies.
- > 25 families have been provided working capital and 75 families benifited
- 125 women have been trained in sewing machine operation and garment making
- 65 women have been self employed and getting Rs 4,000/- to 6,000/- per month.
- > 10 women are provided with continuous work for value addition on blouses and cushion covers

Skill Development Training in Computer Education:

During 2021-22 Chaitanya Bharathi with the support of DATA PRO Visakhapatnam under DDUGKY project taken up the Skill Development Training in Computer Education at Vizianagaram. Under this programme 35 students (Boys & Girls) in each batch for a period of 3 months have been given training in Tally & Hard Ware with free boarding and Lodging and free cost of training. After successful training the trainees will be provided with placements. Already three batches have completed the training and 95% of the trainees have got placements in suitable trades.

Awareness camps On Swachh Bharat Mission:

During this reporting period four awareness camps on Swachh Bharat Mission have been conducted in R.B. Puram, Baljipeta, Nellimarla and Jami Mandals. The resource person Mr R.S Murty addressed the camps and sensitized the community on the importance of Swachh Bharat Mission. He outlined that Swachh Bharat Mission was launched on 2nd October 2014 by the Honorable Prime Minister of India with an aim to achieve Swatch Bharat by 2020 as a fitting tribute to the 150th birth anniversary of Mahatma Gandhi with in rural areas. He covered various topics like sanitation coverage and open defecation free GPs, accelerate the efforts to achieve universal sanitation coverage and to put focus on school sanitation, menstrual hygiene management (MHM), construction and usage of individual house hold latrines, provision of safe drinking water, proper utilization and maintenance of existing water resources, solid and liquid waste management, plantation of trees, removal of silt and other waste materials in the canals keeping wards, streets and villages neat and clean by maintaining environmental sanitation and advised the participants to wash hands after going the toilet and before eating the food to maintain individual hygiene practices. He stressed that the mission shall strive for removing the bottle necks that were hindering the progress.

Awareness camps on Water, Sanitation and Hygiene (WASH) :

Three awareness camps on Water, Sanitation and Hygiene (WASH) have been conducted during the reporting period in Parvatipuram, S. Kota and Gajapatinagarm respectively. The main objective was to streamline the community for consumption of safe drinking water and maintenance of better sanitary practices in their villages for

protection of their health. Water and sanitation are two important components which are not being seen as an end but as a means of benefit. Mr. N. Tulasi Naidu an expertise in water and sanitation, as a resource person addressed the meetings. On this occasion he deplored that safe drinking water and good sanitary conditions are very vital and plays a key role in safe guarding one's life from various diseases. He pointed out that scarcity of safe drinking water, unhealthy hygienic conditions and poor sanitary practices had a great blow to the human being and leads to suffer with several water born diseases like Cholera, Diarrhea, Dysentery, Skin infections, Malaria, Guinea etc. He also stressed the importance of clean and green around the villages, plantation of trees, open defecation free villages, cleaning of existing drains in the villages to protect from mosquitoes, safe drinking water, institutional deliveries focus on proper care Menstrual Hygiene Management, school sanitation, Usage of house hold latrines with adequate water supply, Rapport building with SSBM(G), SWSM, DSBM(G), DWSMC , Village water and sanitation committee, Line departments, PRI members, CBOs, NGOs, SHGs, School children, Civil society, Teachers etc. He also pointed out that maintaining of clean and neat schools . PHC centers , Anganwadi Centers and other local Govt Officers makes the environment Green and Clean . He stressed that Information, Education and Communication plays a key role for achieving total sanitation and to reach the goal of Swachh Bharat through WASH services to protect the Health and Wealth of the Communities. Lack of these three components not only drains the economy of the people but also adverse affect on the life. He underlined that unity and integrity among the people without any discrimination and bias in mobilizing the resources as well as using the existing resources by proper care and management with strong leadership qualities would not only protect the assets but also the health. These awareness camps sensitized the community and the community drew their attention by realizing the importance of the two components i.e. water and sanitation.

Awareness camps on Forest Protection :

Two awareness camps have been conduction on environment and forest protection during the reporting period at Reedivani Valasa and Kuneru Mr. G.Vinod forest ranger as resource person addressed the said camps. On this occasion various topics have been covered on protection of environment and a forestation for maintaining ecological balance. He explained that deforestation is a great blow to the environment and cautioned that uneven climate, unseasonal rain erotic rainfall spoils the ecological system. He emphasized that production of commercial crops, high yielding varieties and marketing system. The Resource person V.Padma has trained SHG members on the procurement of MFP, Adda leaf, and its value addition.

Training on SHG Management:

Three training camps on leadership development and SHG management have been conducted during the reporting period in Kottaki, Denkada and Garividi. The role of women is very important for their individual development and society as a whole. Formation of SHG means to promote leadership quality among the women and empower them. The resource person R. Padmini imparted training to the participants. The focus was paid on the role of SHG, promotion of leadership qualities, savings and thrift, internal lending, bank linkages, conducting of regular meetings, maintenance of books of accounts and other records, repayment of loan, involvement of women in developmental activities, economical empowerment etc., The trainings infused confidence and oriented the women to gain knowledge on their roles and responsibilities for SHG management.

Awareness camps on Organic Farming Practices:

Three awareness camps on Organic Farming Practices have been organized during the year 2021-22 in Arikathota, Narisipuram, K. Rega. Speaking on the occasion the resource person

N. Gopal Rao exhorted that the inorganic agricultural practices leads to environmental pollution, reduces soil fertility, water absorption capacity, land degradation, low yield, high investment and also causing many diseases to the humanity. He sensitized the community about the importance of the organic form practices preferable with using farmyard manure, neem cake, neem oil, bio-fertilizers and vermin compost etc gives more quality and quantitative yield with less investment and the Organic farming practices also useful for maintenance of eco balance and promotes soil fertility, more productivity and more output with less input and better remunerative price for the produce.
